## Overview of Pharma Programs

## Goals of the Pharma Program

- ✓ Designed to support healthcare initiatives
- ✓ Streamline the clinical trial process
- ✓ Facilitate medical education activities
- ✓ Support encompasses the entire lifecycle
  - ✓ Initial qualification and submission
  - ✓ Approval
  - ✓ Post-award analysis

# Expanded Access Program (EAP)

## **Expanded Access Programs**

Compassionate Use or Managed Access Programs (MAPs)



Access to investigational medical products (drugs, biologics, medical devices)



Intended for patients with no comparable or satisfactory alternative treatment options



Aims to provide hope and potential treatment option to those facing dire medical circumstances



#### **Process**

Physician registers account and begins initial request to access a drug

Continued monitoring of the patient's ongoing treatment with resupplies as needed



Assessment of clinical benefits to determine if continuing resupply or closing request



# Investigator Initiated Trials Program (IIT)



## Investigator Initiated Trials Program

Research Program

- Clinical trials initiated and led by:
  - Individual investigators
  - Research groups

Investors apply

Concept approved

Move forward with IIT protocol



## Investigator Registration

• Can register as an individual or an institution

## IIT Application Types

Consists of two proposal types: concept and protocol

### **IIT Concept Submission**

Small application that captures the basics of the study

## IIT Concept Review & Approval

- Administrator reviews and approves/rejects the concept
- If approved, converted into an IIT Protocol

#### **Protocol Submission**

Investigator fills out protocol details (more info) and resubmits

## Protocol Review & Approval

Administrator reviews and proceeds with workflow



## Medical Education (MedEd)

### **Medical Education**

#### Independent Medical Education Grant

IME Grants provide funding for independent medical education activities or initiatives.

These serve to maintain, develop, or increase the knowledge, skills, and/or professional performance of a healthcare professional.

#### Examples of these activities include:

- Continuing medical education
- Continuing health education
- Continuing education





#### MedEd Process

Application submitted – audience, objective and budget


Program admin approves application and funding is released


Organizations

Sometimes combined with proposals for industry specific memberships or charitable donations



Request captured in worksheet that can include multiple events



## Charitable Donations



### Charitable Donations

These are not tied to a company's own strategic initiatives but aim to support the work of NPOs more broadly - like providing funding to a non-governmental organization to support construction of an orphanage in a developing country.

#### Application involves:

- Demonstrating the impact the NPO will have with the requested funding and,
- Aligning the donation with the company's charitable giving priorities and guidelines





## Membership Fees



## Membership Fees

You can also provide funding for industry-specific memberships such as:

- Memberships in professional organizations
- Memberships in trade associations
- Memberships in medical societies

This can help support an organizations involvement and engagement within their particular field.
